
It began with a problem: The City of Sutherlin needed a place to store treated effluent during the summer, when it was prohibited by the Oregon Department of Environmental Quality from releasing into Calapooya Creek.

In 2014, the City purchased the 200-acre Ford's Pond property, which included the 90-acre Ford's Pond, a former logging pond. Plans to upgrade the wastewater treatment plant to produce Class A effluent created the possibility for unrestricted public access to Ford's Pond. Local citizens saw this as an opportunity as Ford's Pond was historically popular for fishing and birding. They suggested the City develop the property as both a wastewater storage pond and a new recreational area, creating an asset for citizens and the local tourism industry.

The Friends of Ford's Pond has a vision of an open-space, natural community park at Ford's Pond with safe, year-round access. Sutherlin is expanding on its west end, but is unable to fund any new parks for nearby residents. The Friends of Ford's Pond, a non-profit organization, will assist the City in raising funds and organizing volunteers. We entered into a partnership with the City in March 2015.

We see the potential and possibilities to develop Ford's Pond as a place where residents and visitors can enjoy healthy, outdoor activities and serve as a model of what citizens and small cities can achieve by working in partnership. Our first major goal is to assist the Sutherlin Parks Advisory Committee with a master design plan. No recreational improvements are permitted until Ford's Pond begins receiving effluent, no earlier than 2019.
